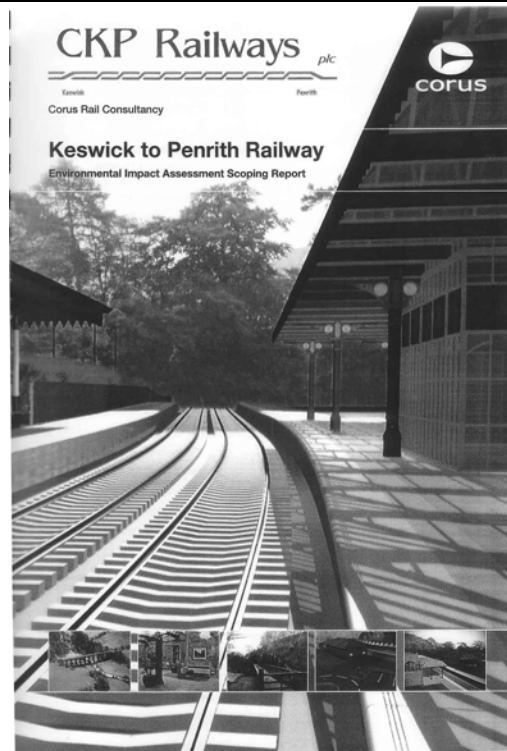

### **FIRST STAGE OF CONSULTATION COMPLETED**

**The Scoping Report, the first stage of the Environmental Impact Assessment, is now being prepared for Government scrutiny. This report examines all the environmental challenges which may arise from construction and operation of the Railway, collates existing information, and assesses whether positive or negative consequences are likely.**

**Where there are potentially serious impacts, the needs for further study are identified.**

**The Report also identifies planning policies which affect the line, and any impact which the Railway may have on those policies.**

**A draft of the report was circulated to about 60 organisations including local authorities, conservation bodies, users of the countryside and other national organisations for comment. Many positive reactions were received.**

**Nothing can be taken for granted - effects on landscape, wildlife, people, archaeology, heritage features, buildings, traffic and air quality all have to be assessed and quantified.**

**This is a major exercise, but selected specialists are being used to ensure a professional result.**

## **KESWICK - A BEACON TOWN**

Keswick has been named as a 'Beacon Town' by the Countryside Agency – one of just six across the whole country. Keswick is already in the Market Towns Initiative and will provide information about tackling challenges in rural areas. Keswick will aim to be a leader in business improvement.

A partnership led by the Countryside Agency, the Northwest Development Agency (NWDA), local authorities and business people, test the suitability of Business Improvement Districts (BIDs) and find out how they could help other market towns.

This follows interest shown by John Prescott, the Deputy Prime Minister, who identified two key factors in regenerating the area as affordable housing and improved transport links (see Update 23).

## **COMMUNITY RAILWAYS**

The Strategic Rail Authority (SRA) has announced proposals to change the management of parts of the existing National Rail network to allow it to more accurately reflect local needs.

The proposals include locally controlled timetabling and maintenance.

These proposals largely reflect the work done over the last few years by the Transport Research and Information Network (TR&IN), who have shown that local management and community involvement can produce a service which people actually want to use, turning round the fortunes of lines which were previously considered uneconomic.

This is the kind of Railway which CKP Railways aims to create for Keswick - as part of the community serving everyday transport needs. In many ways it is ahead of its time - the SRA is now beginning to catch up with it !

The Keswick to Penrith project is the first to be funded entirely by investments directly from people who want a proper transport link reinstated. Local residents, businesses, and supporters further afield have now invested almost £300,000 in design and development - which is progressing steadily. Grants and commercial funding for the later stages, including construction, are being pursued.

## **PROGRESS WITH FLUSCO**

At Flusco, between Penruddock and Blencow, Inglewood Properties is creating an Industrial Park. The trackbed of the Keswick to Penrith line crosses the site diagonally. Inglewood Properties Ltd. submitted plans for an internal access road which would cut through the Railway trackbed.

This could make the line more difficult or unduly expensive to rebuild, or hazardous to operate.

There has been considerable correspondence with Eden District Council to ensure that the constraints on building and operating a fast modern Railway are properly understood.

Eden District Council also sought independent opinions on legal and technical aspects.

CKP Railways, its designers (Corus Rail Consultancy) and planning advisors (AXIS) are hopeful that a solution can be devised which accommodates everyone's needs. There is no need to have one project blocking another, but understanding and communication are essential.

## **BONDS - NEARLY £300,000 ALREADY SOLD**

The Third Offer for Bonds is still open.

Bonds are offered in multiples of £100 and pay interest each year at the rate of 4% gross.

In the year 2010 they will be redeemable or may be converted into shares in CKP Railways plc.

This is the main source of funding for all the development work. Almost £300,000 has been raised so far, about half the total needed to get the Transport and Works Order from Government.

With that Order, construction can commence with external funding and be completed very quickly.

CKP Railways plc normally issues Bond Certificates at the end of each month.

## **AN EXPENSIVE PROJECT ?**

About £200,000 has been spent on design, development, environmental and legal work over the last three years or so. Almost £300,000 has been raised from the sale of Bonds, supplemented by £1,000 to £1,500 each year from commissions on sales of books, videos, prints, greetings cards, phonecards and rail tickets. Commissions, occasional small grants and donations cover administration costs.

The North West Air Ambulance (which covers Cumbria) needs £60,000 every month to remain operational. It also receives no funding from public bodies.

1. Buy a re-chargeable phonecard for discounted calls from any land-line in the UK and 48 other countries. Minimum call charge is only 3 pence, and no coins are needed in BT phoneboxes! Cards cost £10 each, post free, supplied with £10 credit.  
Top up the card at any time from a credit card using a telephone keypad on a free call.  
15% commission on every sale and recharge goes into the reconstruction project.

Book your rail tickets through "Chester-le-Track" for any journey on the whole National Network, including discounted fares for Railcard holders, etc. Phone Chester-le-Track on 0191-387-1387, quote "CKP Offer" and they will pay 3% of the total sale as commission to CKP Railways plc. The total sale must be at least £25 and must be paid for by credit card. Chester-le-Track also sells tickets "on-line" but these do NOT qualify for the CKP offer.
3. We collect and sell used printer and fax ink-jet and laser cartridges for recycling.
